November 8, 2022 **General Election**

- All Santa Clara County registered voters will be mailed a Vote by Mail Ballot starting 29 days before Election Day. Inactive voters will not receive a Vote by Mail Ballot unless they update their voter registration or contact the Registrar of Voters' office.
- ★ Voters may choose to return the completed ballot by using the Free Prepaid Postage Return Envelope, at ANY Official Ballot Drop Box or ANY Santa Clara County Vote Center!
- Toters can vote in person at any Vote Center location in Santa Clara County. Vote Centers are universal polling places and will be open several days.
- Voters have more options to choose WHEN, WHERE, and HOW to vote. Check inside for more information.

The County Voter Information Guide does not contain a complete list of candidates. A complete list of candidates appears on the sample of the ballot. Each candidate's statement is volunteered by the candidate and is printed at his or her expense.

This Guide contains pages regarding candidate statements and/or ballot measures, analyses, and arguments (whichever apply to your ballot). Arguments in support of or in opposition to proposed measures are the opinions of the authors and have not been checked for accuracy by any official agency.

Although the materials provided in this Guide have been carefully proofread, typographical errors occasionally remain undetected. If a substantive error is discovered after the Guide has been printed, a correction notice will be issued.

Language Assistance

The County of Santa Clara provides voting materials in English to all registered voters. In addition, as required by law, the Santa Clara County Registrar of Voters provides voting materials in Chinese, Spanish, Tagalog, and Vietnamese. Official Ballots are produced in the additional languages of Hindi, Japanese, Khmer, and Korean. Facsimile Ballots are available upon request in Gujarati, Nepali, Punjabi, Tamil, and Telugu languages. To ensure our records are correct, the County began conducting a Preferred Language Survey in November 2004. Voters may change their language preference at any time by calling the office or by mailing/faxing in a completed VOTER'S ACTION REQUEST FORM located in this guide.

The office of the Registrar of Voters continues to prioritize multilingual services to improve services to all voters, including those who primarily speak another language other than English.

Dear Santa Clara County Voter,

I hope you are doing well and preparing your voting plan for the November 8, 2022 General Election. Every ten years following the census, California's district lines are redrawn. You may find your districts may have changed since the last time you voted. You can find more information about redistricting and how to look up your districts inside of this Guide.

Santa Clara County is conducting elections under the California Voter's Choice Act model, which was successfully implemented in the March 3, 2020 Presidential Primary Election. Here are some key benefits to your voting experience:

- You choose how to vote: You can vote through the mail (all voters will automatically be mailed a ballot 29 days before Election Day), at a Vote Center or drop off your ballot at an Official Ballot Drop Box.
- You choose when to vote: You can vote at our office beginning 29 days before Election Day or you have up to 11 days, including Election Day, to vote at any Vote Center.
- You choose where to vote: You can visit any Vote Center in Santa Clara County. All Vote Centers will have enhanced voting equipment and will be staffed to provide assistance in multiple languages, helping voters with disabilities, and updating your voter registration information. If you choose to vote at a Vote Center, we will be following the current health and safety guidelines in place at the time.

All Vote Centers will be offering Conditional Voter Registration allowing voters to register to vote and cast a ballot even if they missed the voter registration deadline. Locations and hours of the Vote Centers are available in this Guide and posted online at **www.sccvote.org**.

For Vote by Mail voters, the Registrar of Voters' Office continues to offer prepaid postage for voters returning their ballots by mail as long as it is mailed in the United States.

To increase efficiency, save taxpayer funds, and reduce the impact on the environment, the Registrar of Voters' Office offers all of the information in this Guide online as a downloadable PDF file in a format that is also accessible for persons with disabilities. If you would like to receive your Guide electronically, visit the Registrar of Voters' Office website at **www.sccvote.org** and click on the **"Go Green"** icon.

Information for Voters with Disabilities

REMOTE ACCESSIBLE VOTE BY MAIL SYSTEM

Voters with disabilities can now vote privately and independently by marking their ballot in a screen-readable format from a home computer using their own assistive technology.

All voters are able to access their specific ballot by visiting www.sccvote.org/RAVBM starting 29 days before Election Day and entering their information through a secure portal. All ballots must be printed and follow the return instructions provided at the portal.



Voters can return their voted ballot by mail (must be postmarked by Election Day), or at any Official Ballot Drop Box, or at any Vote Center location.

IN PERSON VOTING

The Registrar of Voters strives to provide Vote Center locations that are accessible to the elderly and voters with disabilities.

The County of Santa Clara's new electronic voting system gives visually impaired voters the ability to cast a secret ballot without assistance. The voting system is equipped with an audio voting component that allows voters to listen to the ballot and make their choices using the keypad provided. The keypad includes a "sip and puff" feature as well.

Voters who are unable to mark a ballot may bring up to two individuals to assist them in voting.




Paper Ballot Voting Instructions

How to Mark Your Paper Ballot:

- Fill in the Oval to the right of your selection completely
- When voting from home, use a black or blue ink pen. NO RED INK.
- When voting at Vote Center, use marker provided.
- O Do not use check marks, X's, lines or circles
- No personal info or identification marks on your Official Ballot

Write-In Voting:

- Print the name of the qualified write-in candidate in the blank space provided
- Fill in the oval completely to the right of the write-in space
- Do not write in a candidate name already printed on the ballot



If you make a **mistake**, request a replacement Ballot or if there is not enough time to receive a replacement ballot by mail, you may correct it by crossing out the wrong choice and filling out the correct oval as shown in picture.

Your voted ballot MUST be returned by 8 p.m. on Election Day OR postmarked on or before election day and received no later than <u>7</u> days after Election Day.

Deliver or mail your ballot early, so it can be included in the first Election Night Results!

- ✓ Return at a Vote Center
- ✓ You may authorize in writing someone other than the voter to return Ballot

Voter-Nominated and Nonpartisan Offices

All voters, regardless of the party preference they disclosed upon registration, or refusal to disclose a party preference, may vote for any candidate for a voter-nominated or nonpartisan office. The party preference, if any, designated by a candidate for a voter-nominated office is selected by the candidate and is shown for the information of the voters only. It does not imply that the candidate is nominated or endorsed by the party or that the party approves of the candidate. The party preference, if any, of a candidate for a nonpartisan office does not appear on the ballot.



CITY ATTORNEY'S IMPARTIAL ANALYSIS OF MEASURE F

Chapter 400 of the Title 1 of the City of Milpitas contains the City's current term limits on Mayoral and City Council service. At present, a person may not serve more than a combined total of three consecutive elective terms as either Mayor or as a Councilmember. However, if a Councilmember is elected Mayor or the Mayor is elected as a Councilmember, the official may serve an additional term for a combined total of four consecutive elective terms. Once the elected official reaches their respective term limit, he or she may not serve for a "cooling off period" of at least two years and may then serve again in elective office.

On June 21, 2022, the City Council voted to place Measure F on the November 8, 2022 General Municipal Election. If approved by a majority of voters, Measure F would amend Chapter 400 of Title 1 of the Municipal Code to make the following changes to local term limits:

- A person may not serve more than a combined total of ten consecutive years of elective service, whether as Mayor or a City Councilmember. If the ten year term limit is reached, the officer may not serve for a "cooling off period" of at least two years and may then serve in elective office again (as Mayor or Councilmember) for a new term limits period.
- Further, one may not serve more than a total of six years as Mayor (three elective two-year terms) within the ten consecutive year combined limit total. If the Mayor reaches the six year term limit, he or she may (i) run for one elective four-year term as a Councilmember, provided the Mayor has four years remaining within his or her respective ten consecutive year combined term limit; or (ii) choose not to serve in elective office for a "cooling off period" of at least two years, after which he or she may then serve in elective office again (as Mayor or Councilmember) again for a new tenconsecutive-year term limits period.

An "elective term" under Measure F includes those terms to which a person was actually elected or appointed to in lieu of an election under California Elections Code 10229. However, a partial term to fill a mid-term vacancy is not deemed to be a "term" covered by Measure F.

Any person who serves one-half or more of either a Councilmember or Mayoral elective term shall be deemed to have served that entire elective term (all years) consecutively with the next scheduled elective term, even if there is an actual break of time in elected service.

Recognizing that Milpitas already has term limits in place, Measure F also includes transitional rules to address the elective terms of current incumbents.

Measure F requires simple majority approval of Milpitas voters to pass.

Activate the voting machine by inserting the Voter Card into the yellow slot at the bottom of the voting machine.

Choose the language in which you wish to vote.

Make your selection by touching the candidate's name or measure response of your choice. A black checkmark will appear in the square next to the choice.



To change your selection, touch the selected choice again. The checkmark will disappear and you may make a new selection.

To vote for a qualified **write-in** candidate choice, touch the word **"WRITE-IN"**. When the keyboard screen appears, touch the letters of the candidate's name, then touch the **"ACCEPT"** button in the lower right-hand corner of your screen to continue.

Conditional Voter Registration

Conditional Voter Registration (CVR) extends the existing 15-day registration deadline to eligible voters, allowing them to register and vote 14 days prior to an election through Election Day. An eligible voter would need to register at the County of Santa Clara Registrar of Voters' Office or a Vote Center to conditionally register to vote and vote a conditional ballot.

CVR ballots will be issued at the Registrar of Voters' Office and Vote Centers. Conditional ballots will not be mailed to voters.

In order to conditionally register, the voter must first complete an affidavit of registration. The affidavit is conveniently located on the front side of the CVR envelope. Once the affidavit is complete and submitted to the election official, a conditional ballot will be issued to the voter.

The affidavit will be processed and once the eligibility is determined and validated, the registration will become permanent and the conditional ballot will be counted. Conditional Voter Registrations are treated and processed in the same manner as other Voter Registration Applications; conditional ballots are treated and processed the same as provisional ballots.

CVR was enacted in 2012, to be operative on the January 1st after the certification of a statewide voter registration database. VoteCal, California's statewide voter registration database, was certified on September 26, 2016; CVR became operative as of January 1, 2017. Effective January 1, 2017, Conditional Voter Registration is available to eligible voters in California pursuant to Election Codes 2170 through 2173.



VOTER BILL OF RIGHTS

YOU HAVE THE FOLLOWING RIGHTS

- 1. The right to vote if you are a registered voter. You are eligible to vote if you are:
 - ★ a U.S. citizen living in California
 - ★ at least 18 years old
 - ★ registered where you currently live

- ★ not currently serving a state or federal prison term for the conviction of a felony
- not currently found mentally incompetent to vote by a court
- 2. The right to vote if you are a registered voter even if your name is not on the list.

You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.

- 3. The right to vote if you are still in line when the polls close.
- 4. The right to cast a secret ballot without anyone bothering you or telling you how to vote.
- 5. The right to get a new ballot if you have made a mistake, if you have not already cast your ballot. You can: Ask an elections official at a polling place for a new ballot, Exchange your vote-by-mail ballot for a new one at an elections office, or at your polling place, or Vote using a provisional ballot.
- 6. The right to get help casting your ballot from anyone you choose, except from your employer or union representative.
- 7. The right to drop off your completed vote-by-mail ballot at any polling place in California.
- 8. The right to get election materials in a language other than English if enough people in your voting precinct speak that language.
- 9. The right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.
- 10. The right to report any illegal or fraudulent election activity to an elections official or the Secretary of State's office.

SPECIAL NOTICE

- Polls are open from 7:00 a.m. to 8:00 p.m. on the day indicated in the posted county Voter Information Guide.
- Specific instructions on how to vote, including how to cast a provisional ballot, can be obtained from a poll worker or by reading the information mailed to you by your local elections official.
- If you are a newly registered voter, you may be asked to provide appropriate identification or other documentation according
 to federal law. But please note that every individual has the right to cast a provisional ballot even if he or she does not provide
 the documentation.
- It is against the law to represent yourself as being eligible to vote unless you meet all of the requirements to vote under federal and state law.
- It is against the law to tamper with voting equipment.
